Operation with an invalid Certificate of Airworthiness and/or Type Certificate is a contravention of the regulations and penalties apply.

Jabiru Aircraft Pty Ltd does not warrant or accept liability for any damage or malfunction caused by non-genuine/unauthorised parts and/or unapproved modifications fitted to any Jabiru Aircraft or Jabiru Engine (and any subsequent damage, including damage or malfunctions to associated parts or systems).
