1 Applicability

2 Background

This Service letter has been released to address potential issues relating to the blockage of the fuel drain line from the mechanical fuel pump.

2.1 General

2.1.1 Fuel pump drain line blockage.

The mechanical fuel pump on the engine has a drain line that drains fuel away from the engine in the case of the diaphragm developing a leak. It has been found that if this line is blocked, operation of the fuel pump can be affected. The usual reason for blockage is that the ties that hold the drain line have crushed the drain line flat.

If the fuel pump drain line is found to be blocked or as a preventive measure, the ties that hold the drain line can be changed to a configuration that won't crush the tube.
